## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 14ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.55mm width (at base) x 1.52mm depth, and a 'cross over' style underrail.

Feature cushion shaped top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of twelve round brilliant cut diamonds, claw set. The top plate is supported by the underrail and in between the extended and square shoulders, of the plain and polished band. Each of the shoulders, has one row of nine round brilliant cut diamonds, claw set.



Polished finish.

Stamped '14K 0.50 michael hill' - acid tested as 14 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "J".

Dimensions = 4.18mm(L) x 4.15mm(W) x 2.53mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.26ct (estimated - see NOTE below)

Thirty claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 2.56 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
