## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand crafted, 18ct yellow gold and platinum, 'solitaire' design, diamond ring.

Plain, narrow, tapered band of 1.34mm in width (at base) x 1.00mm depth, with open back setting.

Feature platinum coronet style setting, housing one round brilliant cut diamond, claw set. Secured between the 'leaf' style extended shoulder plates, of the yellow gold plain and polished band.

Polished finish.

Stamped '18CT PLAT' - acid tested.

Finger size is K.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P1', colour 'H'.

Dimensions = 5.90mm(L) x 5.81mm(W) x 3.76mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.82ct (estimated - see NOTE below)

Total Item Weight = 2.04 grams

Total Gemstone Weight = 0.82ct

Total Metal Weight = 1.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
