Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 15ct yellow gold, cluster style, gem set, dress ring. Plain, narrow, tapered band of 2.45mm in width (at base) x 1.34mm depth, with cut-out underrail, and open back setting.

Feature central 'cluster' style ring design, housing one oval cut and faceted natural sapphire, eight claw set. Surrounded by eight round diamonds (largest), also claw set. All secured between the tri-split shoulders of the plain and polished band. Each shoulder having a central extended section, bead set with one single cut diamond.



Polished finish - stamped '15CT' - acid tested as approximately 15 carat gold. Finger size is O 1/2.

The ring contains:

One claw set mixed cut oval shape natural sapphire, colour 'dark blue/green'.

Dimensions = 4.85mm(L) x 3.55mm(W) x 2.43mm(D-estimated)

Total Weight = 0.36ct (estimated - see NOTE below)

Five old cut and Three round brilliant cut (mixeds) diamonds, clarity 'Si & Pl' (mixed), colour 'H' (ave.).

Dimensions (average) = 2.60mm(Dia) x 1.85mm(D-estimated)

Total Weight = 0.60ct (estimated - see NOTE below)

Two bead set single cut diamonds, clarity 'Si', colour 'H'.

Dimensions = 1.70mm (ave. diameter)

Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 4.39 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 4.19 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. Many claws are missing and/or wearing. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
