## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct white gold, multistone, gem set ring, of cast construction. Plain, wide, tapered band of 3.71mm in width (at base) x 1.37mm depth, with a curved and pierced 'ladder' style underrail.

Feature central four 'corner' claw, bezel setting, with pierced 'scroll' style sides, housing six Princess cut diamonds, invisible set. The centre section of each shoulder, being extended and channel set with ten baguette cut and tapered baguette cut (mixed) diamonds, tapering in size. Finishing with the outer row either side, spanning across the top of the plain and polished band, each having thirteen round brilliant cut diamonds, tapering in size, bead set. Polished finish - stamped '14KT Js(with diamond symbol) - acid tested as 14 carat gold. Finger size is N.



The ring contains:

Six invisible set Princess cut diamonds, clarity 'P1', colour 'H'.

Dimensions (average) = 3.15mm(L) x 3.12mm(W) x 2.00mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.00ct (estimated - see NOTE below)

Twenty channel set baguette cut & tapered baguette cut (mixed) diamonds, clarity 'P1 to P3' (mixed), colour 'H to I' (mixed).

Dimensions = 1.71mm(L) x 0.90mm(W) x 0.45mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.69mm(L) x 1.28mm(W) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.35ct (estimated - see NOTE below)

Twenty Six bead set round brilliant cut diamonds, clarity 'P1 to P3' (mixed), colour 'H to I' (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.45ct (estimated - see NOTE below)

Total Item Weight = 8.28 grams - Total Gemstone Weight = 1.80ct - Total Metal Weight = 7.92 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
