Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled raised, 18ct yellow gold & gemset, multistone ring. Plain, wide, low half round, tapered band, measures 4.33mm width (at base) x 1.08mm depth, with cut-out underrail, open back settings, underneath.

Feature, "square hexagonal cluster style" design, with shoulder stones. Comprising, a raised cluster to top, houses nine round brilliant cut diamonds. Drops to a surround, containing twenty four round brilliant cut diamonds, all bead set. The extended shoulders, of the band tapers up wide to the top, each shoulder, having a double row, contains eighteen round brilliant cut diamonds, bead set, both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = S1/2.

The ring contains;

Nine bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 1.85mm (average diameter) x 1.32mm (D-estimated)
Total Weight = 0.26ct (estimated - see NOTE below).

Sixty bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 1.02mm (average diameter) x 0.62mm (D-estimated)
Total Weight = 0.24ct (estimated - see NOTE below).

Total Item Weight = 10.77 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 10.67 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
