Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 18ct yellow gold & platinum tipped, gemset, multistone ring.

Plain, narrow, low half round, tapered band, measures 1.90mm width (at base) x 0.79mm depth, with curved underrail, open back settings, underneath.

Feature, "cluster style" ring design. Comprising, a raised circular cluster setting with platinum tips to top, houses seven early brilliant cut diamonds. claw set. The extended shoulders, of the band tapers up to pointed end terminations to both sides.

Polished finish, stamped "18ct, PPlat" - acid tested as 18 carat gold.

The ring contains;

One claw set early brilliant cut diamond, clarity is "P2", colour is "H", medium cut quality.

Dimensions = 3.14mm (average diameter) x 1.75mm (D-estimated)

Total Weight = 0.11ct (estimated - see NOTE below).

Six claw set early brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.

Dimensions = 2.32mm (average diameter) x 1.46mm (D-estimated)

Total Weight = 0.29ct (estimated - see NOTE below).

Total Item Weight = 1.97 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 1.89 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
