### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'dress' style ring, of handmade construction.

Plain, narrow, low half round, tapered band of 3.34mm width (at base) x 0.81mm depth, with open back settings.

Feature central white gold three claw setting, housing one pear shaped natural aquamarine, claw set. The setting is secured between the tapering shoulders of the plain and polished yellow gold band. Each of the shoulders is embellished with one round brilliant cut diamond, gypsy set.

Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: O 1/2.

The ring contains



One claw set pear shaped natural aquamarine, colour is "blue".

Dimensions = 9.14mm(L) x 5.58mm(W) x 3.94mm(D-estimated)

Total Weight = 1.00ct (estimated - see NOTE below)

Two gypsy set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G".

Dimensions (average) = 2.94mm(L) x 2.91mm(W) x 1.75mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 4.59 grams Total Gemstone Weight = 1.18ct Total Metal Weight = 4.35 grams (estimated)

NOTE: The central aquamarine has significant abrasion to the crown facets. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
