## Valuation For Traditional Insurance Replacement Purposes

## Item 1

One, 14ct yellow gold, multistone, gem set ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.60mm in width (at base) x 0.76mm depth, with curved and split underrail, and hollow open back settings.

Feature central four claw railed setting, housing one emerald cut natural ruby, claw set. To either side is a a series of 'leaf' style designs, in two tapering rows, housing a total of twelve round brilliant cut diamonds, slightly tapering, bead set. All secured between the split shoulders of the plain and polished band.



Polished finish - unstamped - acid tested as 14 carat gold. Finger size is N.

The ring contains:

Twelve claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to I' (mixed). Dimensions (average) = 1.50mm(Dia) x 0.90mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.10ct (estimated - see NOTE below)

One claw set emerald cut natural ruby, colour 'medium dark red'. Dimensions = 4.78mm(L) x 4.62mm(W) x 2.23mm(D-estimated) Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 1.70 grams - Total Gemstone Weight = 0.60ct - Total Metal Weight = 1.58 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
