## Valuation For Traditional Retail Insurance Replacement

### Item 1

One set of 3 lady's hand-assembled 14ct yellow gold rings consisting of a diamond set round cluster feature ring and 2 band style rings, diamond set.

Flat, parallel 5.6mm in total width x 1.26mm in depth shanks. Feature ring having shoulders bead set with round brilliant cut diamonds. Shoulder sides having a foliate pattern. To centre of ring a split level round cluster setting, bead set with round brilliant cut diamonds. To each side a parallel band, bead set with round brilliant cut diamonds and having foliate patterned sides. Polished finish, stamped " 14K " on each ring and acid tested. Finger size = L 1/2



The rings contain:

Seven bead set round brilliant cut diamonds, clarity "P1 & P2", colour "H", medium to good cut quality.

Dimensions = 1.69mm(Diameter) x 1.03mm(D-estimated) (smallest)

Dimensions = 2.34mm(Diameter) x 1.43mm(D-estimated) (largest)

Total Weight = 0.19ct (estimated) see NOTE below

Seventy Eight bead set round brilliant cut diamonds, clarity "P1 & P2", colour "G to H", medium to good cut quality.

Dimensions = 1.10mm(Diameter) x 0.67mm(D-estimated) (smallest)

Dimensions = 1.35mm(Diameter) x 0.82mm(D-estimated) (largest)

Total Weight = 0.62ct (estimated) see NOTE below

Total Item Weight = 8.20 grams, Total Gemstone Weight = 0.81ct, Total Metal Weight = 8.04 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weights of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
