## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's, raised, 10ct yellow gold & diamond set, cluster dress style ring. Plain, narrow, low half round, tapered band, measures 2.03mm width (at base) x 0.77mm depth, with open back, underneath

Feature, "cluster dress style" ring design. Comprising, step down pear-shaped, cluster setting, houses sixty two round brilliant cut diamonds & single cut diamonds, claw set. The extended shoulders, of the band, tapers up wide & fluted, to top, both sides.

Polished finish, stamped "10K CI" - acid tested.

Finger size = M1/2.

The ring contains;

Sixty Two claw set round brilliant cut diamonds, clarity is "P3 - ", colour is "I to K"(mixed), medium cut quality.

Dimensions = 1.30mm (average diameter) x 0.79mm (D-estimated) (smallest)

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)

Total Weight = 0.68ct (estimated - see NOTE below).

Total Item Weight = 5.40 grams, Total Gemstone Weight = 0.68ct, Total Metal Weight = 5.26 grams (estimated)

NOTE: Limited gemmological testing, inset. Some of the diamonds are chipped, Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weights of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
