Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone, 'cluster' style ring, of hand finished construction.

Plain, narrow, low half round band of 2.55mm width (at base) x 1.01mm depth, with open back settings.

Feature central four claw setting, housing one emerald cut diamond, claw set. Surrounding is one row of ten single cut diamonds, bead set. The top plate has a pierced gallery and is secured between the shoulders. Each of the shoulders has one row of three single cut diamonds, slightly graduating in size, bead set.

Polished finish. Stamped '18c(partial)' - acid tested as 18 carat gold. Ring size: R 1/4.

The ring contains:

One claw set emerald cut diamond, clarity is "Si1" (mixed), colour is "H" (mixed).

Dimensions = 4.35mm(L) x 2.68mm(W) x 1.58mm(D-estimated) x 1%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Sixteen bead set single cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions = 1.30mm (diameter) (smallest)

Dimensions = 1.70mm (diameter) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 3.28 grams Total Gemstone Weight = 0.45ct Total Metal Weight = 3.19 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
