Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 18ct white gold & gemstone set, cluster dress ring. Plain, narrow, low half round, tapered band, measures, 2.29mm width (at base) x 1.31mm depth, with cut-out underrail.

Feature, "cluster style" ring design, with shoulder stones. Comprising, a raised four claw setting, to top & centre, drops to a surround, bead set. The extended shoulders, shoulders of the band, tapers up to the top, from both sides, bead set, to both sides.

Polished finish, stamped "750, EVE D0.19" - acid tested as 18 carat gold. Finger size = L.

The ring contains;

One claw set square cushion cut, faceted, topaz, colour is "medium blue".
Dimensions = 11.80mm (L) x 11.90mm (W) x 8.12mm (D-estimated)
Total Weight = 9.50ct (estimated - see NOTE below).

Forty bead set round brilliant cut diamonds, clarity is "Vs2 & Si"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 0.80mm (average diameter) x 0.49mm (D-estimated) (smallest)
Dimensions = 1.10mm (average diameter) x 0.67mm (D-estimated) (largest)
Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 7.74 grams, Total Gemstone Weight = 9.70ct, Total Metal Weight = 5.80 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
