Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 14ct white gold & diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures 2.08mm width (at base) x 1.18mm depth, with curved underrail, open back settings, underneath.

Feature, "cluster style" ring design, with undercarriage & shoulder set stones. Comprising, a raised four claw setting to top. Drops to a double claw set surround, The extended shoulders, of the band tapers up, splits and crosses over, end terminations, with a loop around under carriage from both sides, all claw set.

Polished finish, stamped "585" - acid tested as 14 carat gold. Finger size = Q.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P2", colour is "tint light brown", medium cut quality.

Dimensions = 4.60mm (average diameter) x 2.81mm (D-estimated)

Total Weight = 0.36ct (estimated - see NOTE below).

Ninety Four claw set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "J to K & tint light brown" (mixed), medium cut quality.

Dimensions = 0.90mm (average diameter) x 0.55mm (D-estimated) (smallest)

Dimensions = 1.41mm (average diameter) x 0.86mm (D-estimated) (largest)

Total Weight = 0.64ct (estimated - see NOTE below).

Total Item Weight = 5.00 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 4.80 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
