Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, diamond set, 'solitaire' style ring, of cast construction.

Plain, narrow, half round band of 2.68mm width (at base) x 1.36mm depth, with an open back setting, and a 'crossover' style underrail.

Feature central four claw setting, housing one round brilliant diamond, claw set. The claws are created by the 'crossover' style underrail, and the setting is secured between the extended and square shoulders. The shoulders extend out from the plain and polished band.



Polished finish.

Stamped '1.03 14K WL.xt' - acid tested as 14 gold.

Ring size: L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "J".

Dimensions = 6.38mm(L) x 6.36mm(W) x 4.02mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.03ct (estimated - see NOTE below)

Total Item Weight = 4.90 grams
Total Gemstone Weight = 1.03ct
Total Metal Weight = 4.69 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting.
