Valuation for Traditional Retail Insurance Replacement

Item 1

Plain, narrow, low half round band of 2.57mm width (at base) x 1.24mm depth, with an open back setting, and a curved underrail.

Feature central railed four claw setting, housing one round brilliant cut diamond, claw set. The tips of the claws, and the gallery are embellished with a 'heart' design. The setting is secured between the extended and pointed shoulders of the plain and polished band.



Polished finish.

Stamped '10K D1.0CT' - acid tested as 9 carat gold.

Ring size: O 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P3", colour is "J" Dimensions = 6.40mm(L) x 6.37mm(W) x 3.57mm(D-estimated) x 6%(Girdle Thickness) Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 2.41 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 2.21 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
