Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised, 14ct yellow gold & diamond set, drop style open heart style pendant.

Feature, "open heart style" pendant, ribbon to centre. The outer frame & centre ribbon, having claw settings, contains a total of thirty one round brilliant cut diamonds, tapering sizes, claw set. Open back settings, underneath. The back top, to each side a u-shaped bail attached.

Polished finish, unstamped - acid tested & x-rayed as 14 carat gold.

Pendant dimensions = 23.00mm (total length) x 21.38mm (width) x 4.08mm (depth).

The pendant contains:

Thirty One claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "I to J"(mixed), medium cut quality.
Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (smallest)
Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (largest)
Total Weight = 0.75ct (estimated - see NOTE below).

Total Item Weight = 4.23 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 4.08 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
