## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand finished raised, 14ct yellow gold & diamond set, dress ring, of cast construction. Plain, wide, half round, tapered band, measures 3.78mm width (at base) x 1.43mm depth, with open back, setting underneath.

Feature; Solitaire style" ring design. Comprising, a raised rub-over setting to top, open back underneath. The extended shoulders, of the band, tapers up with triple roll-over shoulder terminations, to both sides.

Polished finish, stamped "585" - acid tested as 14 carat gold.

Finger size = M.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "P2", colour is "H", medium cut quality.  
Dimensions = 7.05mm (average diameter) x 4.09mm (D-estimated) x 2%(Girdle Thickness)  
Total Weight = 1.25ct (estimated - see NOTE below).

Total Item Weight = 4.77 grams, Total Gemstone Weight = 1.25ct, Total Metal Weight = 4.52 grams (estimated)

NOTE: Limited gemmological testing, inset. The diamond has a large external fracture to top side. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
