Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.90mm in width (at base) x 0.76mm depth, with a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, largest, claw set. Surrounded by twelve round brilliant cut diamonds, claw set. The setting base being of a tristrut 'V' design, all secured between the extended and upswept shoulders of the plain and polished band.

Polished finish - stamped '18CT PAL' - acid tested. Finger size is N 1/2.

The ring contains:

One claw set early brilliant cut diamond, clarity 'Si', colour 'H'.
Dimensions = 4.64mm(L) x 4.62mm(W) x 2.91mm(D-estimated)
Total Weight = 0.38ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'H'.
Dimensions (average) = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 6.75 grams - Total Gemstone Weight = 0.80ct - Total Metal Weight = 6.59 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. Some corner claws are worn and require replacement. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
