Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and platinum, three diamond ring.

Plain, narrow, tapered band of 1.45mm in width (at base) x 1.13mm depth.

Feature three individual 'coronet' settings, each housing one old cut diamond, largest to the centre, all claw set. Secured between the extended shoulders of the yellow gold plain and polished band.

Polished finish.

Stamped 'PLAT W.18.D' - acid tested.

Finger size is K 1/2.

The ring contains:

Three claw set old cut diamonds, clarity 'P1 & P2' (mixed), colour 'G to H' (mixed).

Dimensions = 3.10mm(ave. diameter) x 2.20mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.60mm(diameter) x 2.56mm(D-estimated) (largest)

Total Weight = 0.43ct (estimated - see NOTE below)

Total Item Weight = 2.17 grams

Total Gemstone Weight = 0.43ct

Total Metal Weight = 2.08 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
