Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, dress style, gem set ring, of cast construction.

Plain, wide, tapered band of 12.11mm at top to 4.73mm in width (at base) x 1.63mm depth, with hollow top and shoulders, and open back settings.

Feature raised 'cushion-shape' top, housing four round brilliant cut diamonds, tapering in size, bead set in a diagonal direction. The band surround and shoulders having a 'bark' style finish.

Polished finish.

Stamped '18K' (partial) - acid tested as 18 carat gold.

Finger size is X.

The ring contains:

Four bead set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).
Dimensions = 2.30mm to 2.40mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 11.82 grams

Total Gemstone Weight = 0.18ct

Total Metal Weight = 11.78 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
