### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, platinum, diamond set, 'solitaire' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.35mm width (at base) x 1.25mm depth, with a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. The diamond is suspended slightly over the curved knife-edge profile underrail. The setting is secured between the extended and square shoulders, of the plain and polished band.

Polished finish.

Stamped 'BULGARI 950PL 54690' - acid tested as platinum.

Ring size: L.

The ring contains:

- One claw set round brilliant cut diamond, clarity is "Vs1", colour is "E".
- Dimensions = 5.14mm(L) x 5.12mm(W) x 3.29mm(D-estimated) x 3%(Girdle Thickness)
- Total Weight = 0.54ct (estimated - see NOTE below)

Total Item Weight = 6.96 grams  
Total Gemstone Weight = 0.54ct  
Total Metal Weight = 6.85 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 16667231 Dated: January 2, 2008. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 16667231. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
