Valuation for Traditional Retail Insurance Replacement

One, 9ct yellow gold and 9ct white gold, flexible link bracelet, of hand-assembled construction

Feature one row of forty five round white gold illusion settings, each housing one round brilliant cut diamond, illusion set. The illusion settings are within articulated yellow gold bezel settings. The bracelet is finished with a box clasp, and a fitted safety catch.

Bracelet dimensions = 18.00cm (ave. length) x 3.83mm (ave. width) x 3.69mm (ave. depth).

Polished finish.

Stamped '9K JP164' - acid tested as 9 carat gold.

The bracelet contains:

Forty Five illusion set round brilliant cut diamonds, clarity is "Si1 & P1" (mixed), colour is "light tinted brown".

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest) Dimensions = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 12.33 grams Total Gemstone Weight = 1.00ct

Total Metal Weight = 12.13 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
