### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, cluster style, gem set, dress ring.

Plain, wide, tapered band of 3.60mm in width (at base) x 0.95mm depth.

Feature white gold central eight claw setting, housing one round brilliant cut diamond, claw set. Surrounded by eight single cut diamonds, slightly varying in size, illusion set. All secured between the extended shoulders of the yellow gold plain and polished band. Each shoulder having one round brilliant cut diamond (smallest), bead set.

Polished finish - stamped '18CT PALL' - acid tested. Finger size is L 1/2.

The ring contains:

One illusion set round brilliant cut diamond, clarity 'Si', colour 'J'.

Dimensions = 3.85mm(Dia) x 2.35mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Ten illusion set & bead set (mixed) single cut (8) & round brilliant cut (2) (mixed) diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).

Dimensions = 1.30mm(Dia) (smallest)

Dimensions = 2.05mm(Dia) (largest)

Total Weight = 0.28ct (estimated - see NOTE below)

Total Item Weight = 6.32 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 6.23 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
