Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand crafted, 18ct yellow gold, cluster style, gem set, dress ring.

Plain, narrow, tapered band of 2.43mm in width (at base) x 1.13mm depth, with open back settings.

Feature central eight claw setting, housing one oval cut and faceted natural sapphire, claw set. Surrounded by twenty round brilliant cut diamonds, also claw set. Secured between the extended 'ramp' style shoulders of the yellow gold plain and polished band.

Polished finish - stamped '18ct' - acid tested as 18 carat gold. Finger size is I 1/2.

The ring contains:

One claw set mixed cut oval shaped natural sapphire, colour 'medium light blue'.

Dimensions = 10.83mm(L) x 7.02mm(W) x 4.30mm(D-estimated)(5-8% bulge)

Total Weight = 2.88ct (estimated - see NOTE below)

Twenty claw set round brilliant cut diamonds, clarity 'Vs', colour 'G to H' (mixed).

Dimensions (average) = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Total Item Weight = 4.37 grams - Total Gemstone Weight = 3.20ct - Total Metal Weight = 3.73 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. Fine chips and abrasion to the sapphire crown. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
