Valuation for Traditional Retail Insurance Replacement

One, hand-assembled, 18ct yellow gold and platinum, 'solitaire' design, diamond set ring.

Plain, narrow, tapered band of 1.10mm in width (at base) x 0.89mm depth, with a curved underrail.

Feature 'solitaire' style ring design, consisting of a white gold six claw setting, housing one round brilliant cut diamond, claw set. Secured between the white gold shoulder plates, all mounted atop the yellow gold plain and polished band.



Polished finish.

Stamped '18CT PLAT' - acid tested.

Finger size is L.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si', colour 'G'.

Dimensions = 4.60mm(Dia) x 2.81mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.37ct (estimated - see NOTE below)

Total Item Weight = 1.98 grams Total Gemstone Weight = 0.37ct Total Metal Weight = 1.91 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting.
