Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.24mm width (at base) x 1.24mm depth, with open back settings, and a curved underrail.

Feature three white gold 'flower' style clusters, spanning across the top of the band, graduating in size, largest to the centre, and claw set. The settings are secured between the extended and pointed shoulders of the plain and polished yellow gold band.

Polished finish.

Stamped 'maple leaf motif 18CT MHJ' - acid tested as 18 carat gold. Ring size: M.

The ring contains:

Seven claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 2.56mm(Dia) x 1.56mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.07mm(Dia) x 1.87mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.48ct (estimated - see NOTE below)

Fourteen claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.94mm(Dia) x 1.18mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.42mm(Dia) x 1.48mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 4.55 grams Total Gemstone Weight = 0.84ct Total Metal Weight = 4.38 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
