Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, white gold, diamond set brooch.

Feature decorative brooch having a curved setting, with a 'ribbon-style' setting, with fine wire terminations, housing a total of twenty-three round brilliant cut diamonds, tapering in size, claw set and bead set (mixed).

Brooch pin with screw down locking mechanism.

Polished finish - stamped '0750' - acid tested as mixed metals, 14 carat and 18 carat gold.

Brooch dimensions = 50.00mm (length) x 25.00mm (width) x 15.30mm (depth)

The brooch contains:

Five claw set round brilliant cut diamonds, clarity 'Si', colour 'G to H' (mixed).

Dimensions (average) = 2.20mm(L) x 1.90mm(W) x 1.16mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.16ct (estimated - see NOTE below)

Eighteen claw set & bead set (mixed) single cut diamonds, clarity 'Si & P1' (mixed), colour 'G to I' (mixed).

Dimensions = 1.10mm(diameter) (smallest)
Dimensions = 1.50mm(diameter) (largest)
Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 6.98 grams - Total Gemstone Weight = 0.34ct - Total Metal Weight = 6.91 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar brooch employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
