### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One lady's, hand-assembled raised, sterling silver & 18ct yellow gold, gemset cluster ring.

Plain, narrow, low half round, tapered. Plain, narrow, low half round band, measures 2.31mm width (at base) x 0.92mm depth with curved underrail, open back setting, underneath. Feature, "pyramid style cluster" ring design. Comprising, a raised silver claw setting to top & yellow gold bottom band. The silver top, housing, one round natural emerald, with a twisted rope design at base, with three alternating levels containing natural & synthetic emeralds (mixed), claw set, with a row of single cut & brilliant cut diamonds (mixed), all claw set. The extended shoulders, of the yellow gold band tapers up to the silver top, from both sides.



Polished finish, stamped '18ct' - acid tested & x-rayed mixed metals. Finger size P1/2.

The ring contains;

Twenty Two claw set round natural & synthetic emeralds (mixed), colour is "medium dark green".  
Dimensions = 2.72mm (average diameter) x 1.66mm (D-estimated) (smallest)  
Dimensions = 3.99mm (average diameter) x 2.43mm (D-estimated) (largest)  
Total Weight = 1.67ct (estimated - see NOTE below).

Seventeen claw set round brilliant cut diamonds, clarity is "Si, P1, P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.  
Dimensions = 1.18mm (average diameter) x 0.72mm (D-estimated)  
Total Weight = 0.10ct (estimated - see NOTE below).

Total Item Weight = 5.80 grams, Total Gemstone Weight = 1.77ct, Total Metal Weight = 5.45 grams (estimated)

NOTE: Limited gemmological testing, inset. A mixture of natural & synthetic emeralds, some heavily included abraded & chipped. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
