Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.04mm width (at base) x 1.50mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of twelve round brilliant cut diamonds, in a 'quatrefoil' shape. The diamonds graduate in size, largest to the centre, and are claw set. The central settings are supported with a decorative gallery, and are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band. Each of the shoulders houses one row of thirteen round brilliant cut diamonds, graduating in size, claw set.



Polished finish. Stamped '750' - acid tested as 18 carat gold. Ring size: J.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs1", colour is "I".

Dimensions = 5.12mm(L) x 5.12mm(W) x 3.20mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.51ct (known weight - see NOTE below)

Thirty claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to I" (mixed).

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.37mm(Dia) x 0.84mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 3.52 grams Total Gemstone Weight = 0.78ct Total Metal Weight = 3.36 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 2238159752 Dated: Jul.13, 2016. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2238159752. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
