Valuation for Traditional Retail Insurance Replacement

Item 1

One, platinum, gem set, multistone ring, of hand-finished construction.

Plain, wide, low half round band of 4.13mm width (at base) x 1.97mm depth, with open back settings.

Feature one row of twenty, four claw settings, spanning almost all the whole way around the band. Each of the settings houses one oval cut diamond, claw set. The settings are secured between the shoulders of the plain and polished band.

Polished finish.

Stamped 'GR PLAT illegible stamp' - acid tested as platinum.

Ring size: J.

The ring contains:

Twenty claw set oval shaped diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 3.80mm(L) x 2.55mm(W) x 1.56mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 2.00ct (estimated - see NOTE below)

Total Item Weight = 4.96 grams

Total Gemstone Weight = 2.00ct

Total Metal Weight = 4.56 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
