Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised platinum & gemstone, multistone ring. Plain, narrow, low half round, tapered band, measures 2.94mm width (at base) x 1.78mm depth, with curved underrail, open back settings, underneath.

Feature, "single row across" top of the band, comprising, ten round faceted, natural sapphires, claw set. The extended shoulders, of the band, tapers up to the top, from both sides.

Polished finish, stamped "PLAT HD" - acid tested as 18 carat gold.

Finger size = J1/2.

The ring contains;

Ten claw set round natural teal sapphires, colour is "dark bluish/green".

Dimensions = 3.49mm (average diameter) x 2.13mm (D-estimated) (smallest)

Dimensions = 3.55mm (average diameter) x 2.17mm (D-estimated) (largest)

Total Weight = 2.00ct (estimated - see NOTE below).

Total Item Weight = 5.89 grams, Total Gemstone Weight = 2.00ct, Total Metal Weight = 5.49 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
