## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, platinum & 18ct white gold, diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures 2.88mm width (at base) x 1.09mm depth, with cut-out underrail, open back setting, underneath.

Feature, "solitaire style" ring design. Housing one round brilliant cut diamond, rub-over set. The extended shoulders, of the band, tapers up to the top, with a scolloped edge. An 18ct white gold decorative pattern to the centre, both sides.

Polished finish, stamped "025, 750 K18, PT900" - acid tested & x-rayed as platinum & 18 carat gold.

Finger size = M1/2.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality. Dimensions = 3.92mm (average diameter) x 2.52mm (D-estimated) Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 6.61 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 6.56 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
