Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, mixed white metal, & gemset, cluster ring. Plain, wide, low half round, tapered band, measures 2.61mm width (at base) x 1.45mm depth, with cut-out underrail, open back settings, underneath.

Feature, square-shaped cluster set to the angle, housing nine round, faceted, natural sapphires, claw set, mixed with four single cut diamonds, claw set. The extended shoulders, of the band, tapers up to the top, from both sides. The base of the ring, having a square edge profile.

Polished finish, stamped "symbol, 18K, 3955" - acid tested & x-rayed.

The ring contains;

Nine claw set round natural sapphires, colour is "dark blue".
Dimensions = 4.95mm (average diameter) x 3.02mm (D-estimated)
Total Weight = 4.80ct (estimated - see NOTE below).

Four claw set single cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.30mm (average diameter)
Total Weight = 0.04ct (estimated - see NOTE below).

Total Item Weight = 9.86 grams, Total Gemstone Weight = 4.84ct, Total Metal Weight = 8.89 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
