Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gem set, flexible link bracelet, of hand-assembled construction.

Feature one articulated row of fifty-three, four claw settings, each housing one round brilliant cut diamond, claw set. Rhodium plating to the tips of the claws. The bracelet is finished with a box clasp, and a figure 8 safety catch.

Bracelet dimensions = 19.00cm (ave. length) x 3.20mm (ave. width) x 3.28mm (ave. depth).

Polished finish.

Stamped 'SJ 18K' - acid tested as 18 carat gold.

The bracelet contains:

Fifty Three claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).
Dimensions (average) = 2.95mm(Dia) x 1.80mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 5.50ct (estimated - see NOTE below)

Total Item Weight = 14.86 grams
Total Gemstone Weight = 5.50ct
Total Metal Weight = 13.76 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
