Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 18ct white gold & diamond set, cluster style dress ring. Plain, narrow, low half round, tapered band, measures 1.61mm width (at base) x 1.06mm depth, with curved underrail.

Feature, "cluster style" dress ring. Comprising, a raised four claw setting to top, centre. Drops to a double surround, claw set. The extended shoulders, of the band, tapers up, split at the end terminations, to both sides, claw set. A roll-over feature to the under carriage, each side having a bead & rub-over setting, four diamonds, set within.

Polished finish, stamped "18K, Michelle Bevelles" - acid tested as 18 carat gold. Finger size = M1/2.

The ring contains;

One claw set emerald cut diamond, clarity is "Si2", colour is "G", medium cut quality.
Dimensions = 5.32mm (L) x 4.09mm (W) x 2.90mm (D-estimated)
Total Weight = 0.55ct (estimated - see NOTE below).

One Hundred And Eight claw set round brilliant cut & single cut diamonds (mixed), clarity is "P1, P2 & P3"(mixed), colour is "G to I (mixed)", medium cut quality.

Dimensions = 1.01mm (average diameter) x 0.62mm (D-estimated) (smallest)
Dimensions = 1.75mm (average diameter) x 1.07mm (D-estimated) (largest)
Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 5.05 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 4.85 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
