## Valuation for Traditional Retail Insurance Replacement

## Item 1

One hand finished, raised 9ct yellow gold & diamond set, cluster dress ring. Plain, wide, low half round, tapered band, measures 4.83mm width (at base) x 1.55mm depth, with cut-out underrail, open back settings, underneath.

Feature, "oval shaped cluster to top" housing, twenty five round brilliant cut diamonds, bead set. The extended shoulders, of the band, tapers up wide to the top, from both sides.

Polished finish, stamped "9CT" - acid tested as 9 carat gold.

Finger size = R.

The ring contains;

Twenty Five bead set round brilliant cut diamonds, clarity is "Vs, Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)

Dimensions = 2.11mm (average diameter) x 1.29mm (D-estimated) (largest)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 9.34 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 9.24 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
