## Valuation for Traditional Retail Insurance Replacement

### Item 1

One gents, hand finished, raised 18ct rose gold & diamond set, dress ring. Plain, wide, low half round, tapered band, measures 5.64mm width (at base) x 1.01mm depth, tapers up to 15.71mm width (at top), with open back, hollowed out underneath.

Feature, "rectangular shaped" top dress ring, Housing to one corner, a round brilliant cut diamond, star set. A groove line across the top at an angle. The extended shoulders, of the band, tapers up wide, fluted end terminations, to both sides.

Polished finish, stamped "750, 369 VI" - acid tested as 18 carat gold.

Finger size = X1/2.

The ring contains;

One star set round brilliant cut diamond, clarity is "Vs2", colour is "I", medium cut quality.

Dimensions = 4.05mm (Diameter) x 2.47mm (D-estimated)

Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 13.25 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 13.20 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
