Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.68mm width (at base) x 1.27mm depth, with open back (cut out) settings.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the band and in between the extended and pointed shoulders, in a 'wrap around' style. Each of the shoulders has one row of four round brilliant cut diamonds, channel set. The shoulders lengthen out from the plain and polished band.

Polished finish.

Stamped '750 15A&C' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "light tinted brown".

Dimensions = 5.63mm(Dia) x 3.43mm(D-estimated) x 1%(Girdle Thickness)

Total Weight = 0.66ct (estimated - see NOTE below)

Eight round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "light tinted brown".

Dimensions (average) = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 4.34 grams Total Gemstone Weight = 1.06ct Total Metal Weight = 4.13 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
