Valuation for Traditional Retail Insurance Replacement

Item 1

One gents, hand finished, raised 18ct yellow gold & diamond set, dress ring. Plain, wide, low half round, tapered band, measures 3.11mm width (at base) x 1.20mm depth, with curved underrail, open back setting, underneath.

Feature, "dress solitaire style" ring desiogn, Comprising, The extended shoulders, of the band taper up wide with a fluted centre, to top, houses one Princess cut diamond, end set to the angle.



Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = T.

The ring contains;

One end set Princess cut diamond, clarity is "Si2", colour is "J", medium to fair cut quality. Dimensions = 3.87mm (L) x 3.87mm (W) x 2.64mm (D-estimated) Total Weight = 0.32ct (estimated - see NOTE below).

Total Item Weight = 8.16 grams, Total Gemstone Weight = 0.32ct, Total Metal Weight = 8.10 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
