Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow gold & gemstone set, multistone ring. Plain, narrow, low half round, tapered band, measures, 2.61mm width (at base) x 1.09mm depth, with split underrail, underneath.

Feature, "dress style" ring design. Comprising, a raised four claw setting, top & centre, to one side two x three claw settings, The extended shoulders, of the band, tapers up, splits to the top, one side, wraps and curls around the base of the central setting,

Polished finish, stamped "18ct" - acid tested as 18 carat gold. Finger size = S.

The ring contains;

One claw set brilliant cut oval shaped natural sapphire, colour is "medium dark blue".
Dimensions = 7.20mm (L) x 5.26mm (W) x 3.21mm (D-estimated)
Total Weight = 1.00ct (estimated - see NOTE below).

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "I to J"(mixed), medium cut quality.
Dimensions = 2.02mm (Diameter) x 1.23mm (D-estimated)
Total Weight = 0.06ct (estimated - see NOTE below).

Total Item Weight = 3.97 grams, Total Gemstone Weight = 1.06ct, Total Metal Weight = 3.76 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
