Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'dress' style ring, of hand-assembled construction.

Plain, wide, low half round, tapered band of 6.94mm width (at base) x 1.42mm depth.

Feature central cup setting, housing one cultured pearl, cup set. The setting is secured to the top of the band. The central setting is framed with one groove to the top and bottom, running the entire circumference of the band. Each of the shoulders are embellished with one round brilliant cut diamond, gypsy set.

Polished finish.

Stamped '750 australia motif' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One cup set round cultured pearl, colour is "black".

Dimensions = 8.10mm(L) x 8.08mm(W)

Two gypsy set round brilliant cut diamonds, clarity is "Si", colour is "G".

Dimensions = 2.22mm(Dia) x 1.35mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.08ct (estimated - see NOTE below)

Total Item Weight = 12.70 grams

Total Gemstone Weight = 0.08ct

Total Metal Weight = 12.68 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
