Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, dress style ring, of cast construction.

Plain, wide, tapered band of 3.20mm in width (at base) x 0.24mm depth, with hollow top and open back setting.

Feature central white gold multi-claw 'web' style setting, housing one round brilliant cut diamond, claw set. Surrounded by a decorative white gold design, finishing with a yellow gold 'net' style pattern, and white gold shoulder inserts to the yellow gold plain and polished band.

Polished finish.

Unstamped - acid tested and x-rayed as approximately 18 carat gold.

Finger size is P.

The ring contains:

One illusion set round brilliant cut diamond, clarity 'Si', colour 'I'.

Dimensions = 3.00mm(Dia) x 1.83mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.11ct (estimated - see NOTE below)

Total Item Weight = 5.83 grams

Total Gemstone Weight = 0.11ct

Total Metal Weight = 5.81 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
