Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat band of 2.94mm width (at base) x 1.44mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of sixteen round rilliant cut diamonds, claw set. The top plate is secured between the shoulders of the plain and polished band. Each of the extended and square shoulders has two rows of six round brilliant cut diamonds, claw set.



Polished finish. Stamped '14K' - acid tested as 14 carat gold. Ring size: P.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P3", colour is "H".

Dimensions = 6.05mm(L) x 6.03mm(W) x 3.85mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.89ct (estimated - see NOTE below)

Forty claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to J" (mixed).

Dimensions (average) = 1.43mm(Dia) x 0.87mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.56ct calculated

Total Item Weight = 6.33 grams Total Gemstone Weight = 1.45ct Total Metal Weight = 6.04 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
