## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct rose gold and platinum, diamond set, multistone ring, of handmade construction.

Plain, narrow, high half round band of 1.15mm width (at base) x 0.90mm depth, with open back settings, and a curved underrail.

Feature 'vintage' style ring, with a central four claw platinum setting, housing one round brilliant cut diamond, claw set. The shoulders are embellished with stepped 'arrow' shaped platinum shoulder plates, each housing two single cut diamonds, graduating in size, and bead set. The edges are finished with millegrain detail. The top plates are supported with cheniér detail, and are secured to the decorative gallery of the plain and polished rose gold band.

Polished finish. Stamped '18CT P.PLAT' - acid tested as 18 carat gold and platinum. Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "H".

Dimensions = 3.86mm(L) x 3.85mm(W) x 2.34mm(D-estimated) x 1.5%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Four bead set single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 1.30mm (diameter) (smallest)

Dimensions = 1.70mm (diameter) (largest)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 1.36 grams Total Gemstone Weight = 0.28ct Total Metal Weight = 1.30 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
