Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.11mm width (at base) x 1.00mm depth, with open back settings, and a curved underrail.

Feature assymetrical arrangement of twelve two claw settings, housing six marquise natural rubies, and six round brilliant cut diamonds, claw set. The settings are secured between the extended and pointed shoulders, in a 'wrap around' style of the plain and polished band.

Polished finish.

Stamped '750 illegible stamps' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

Six claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.06mm(Dia) x 1.26mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.19ct (estimated - see NOTE below)

Six claw set marquise natural rubies, colour is "red".

Dimensions = 4.39mm(L) x 2.52mm(W) x 1.54mm(D-estimated)

Total Weight = 0.72ct (estimated - see NOTE below)

Total Item Weight = 3.40 grams Total Gemstone Weight = 0.91ct Total Metal Weight = 3.22 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
