## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold and 18ct white gold, diamond set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.25mm width (at base) x 0.84mm depth, with open back settings, and a curved underrail.

Feature central raised white gold four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is two rows, with a total of thirty white gold individual two claw settings, each housing one single cut diamond, claw set. The top plate is supported with an open wire base. The setting is secured to the underrail, and in between the extended and square shoulders, of the plain and polished yellow gold band.

Polished finish.

Unstamped - acid tested and x-rayed as approximately 18 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "I".

Dimensions = 3.25mm(L) x 3.23mm(W) x 1.97mm(D-estimated) x 1.5%(Girdle Thickness)

Total Weight = 0.13ct (estimated - see NOTE below)

Thirty claw set single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.30mm (diameter)

Total Weight = 0.30ct (estimated - see NOTE below)



Total Item Weight = 4.48 grams Total Gemstone Weight = 0.43ct Total Metal Weight = 4.39 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
