## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's raised 9ct yellow gold & gemset, multistone ring. Plain, wide, low half round, tapered band, measures 3.17mm width (at base) x 0.91mm depth, with open back, onderneath.

Feature, raised six claw setting to top, houses one round brilliant cut diamond, claw set. The extended shoulders, of the band tapers up wide, each shoulder contains tow round brilliant cut diamonds, one round, faceted, natural sapphire, all rub-over set.

Polished finish, stamped "9ct" - acid tested as 9 carat gold. Finger size = V1/2.



The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "I", medium cut quality.

Dimensions = 3.88mm (Diameter) x 2.37mm (D-estimated)

Total Weight = 0.22ct (estimated - see NOTE below).

Four rub-over set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)

Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (largest)

Total Weight = 0.06ct (estimated - see NOTE below).

Two rub-over set round natural sapphires, colour is "dark - blue".

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated)

Total Weight = 0.04ct (estimated - see NOTE below).

Total Item Weight = 5.04 grams, Total Gemstone Weight = 0.32ct, Total Metal Weight = 4.98 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
