## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, multistone ring, of hand-assembled

Plain, narrow, low half round, tapered band of 2.67mm width (at base) x 1.34mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature central white gold four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail of the plain and polished yellow gold band. Each of the extended and square tapering shoulders, houses two rows of five Princess cut diamonds, graduating in size, and invisibly set.



Polished finish.

Stamped '18K 750 MHJ iS' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 5.02mm(L) x 4.99mm(W) x 3.10mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.49ct (estimated - see NOTE below)

Twenty invisibly set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.60mm(L) x 1.60mm(W) x 1.14mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(L) x 1.80mm(W) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.66ct (estimated - see NOTE below)

Total Item Weight = 5.92 grams Total Gemstone Weight = 1.15ct Total Metal Weight = 5.69 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
