## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 18ct yellow gold, 'drop' style pendant.

Feature articulated, 'drop' style pendant design, housing one baroque pearl, half drilled and glue set, with a small ring to the top.

Articulated from the tapering bail assembly.

Stamped '750' - acid tested as 18 carat gold.

Polished finish.

Pendant dimensions = 40.00mm (length including bail).

The pendant contains:

One half-drilled baroque cultured pearl, skin having 'many blemishes (spotted)', colour 'cream'.  
Dimensions = 28.00mm(L) x 15.26mm(W) x 13.60mm(D)

One rub over set round brilliant cut diamond, clarity 'P1', colour 'H'.  
Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.008ct (estimated - see NOTE below)

Total Item Weight = 6.77 grams.

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
