Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.80mm width (at base) x 1.14mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one fracture filled Princess cut diamond, claw set. The setting is secured to the underrail of the plain and polished band. Each of the extended and square shoulders, houses one row of seven round brilliant cut diamonds, varying in size, and claw set.

Polished finish.

Stamped '14k' - acid tested as 14 carat gold.

Ring size: N 1/2.

The ring contains:

One claw set fracture filled Princess cut diamond.

Dimensions = 5.24mm(L) x 5.21mm(W) x 4mm(D-estimated) x 6%(Girdle Thickness)

Total Weight = 1.00ct (estimated - see NOTE below)

Fourteen claw set round brilliant cut diamonds, clarity is "Si" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Total Item Weight = 2.07 grams Total Gemstone Weight = 1.17ct Total Metal Weight = 1.84 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, the weight of the diamond is very much an estimation. The diamond has been enhanced by means of filling with a glass type substance. This treatment is not stable and can be damaged by heat or ultrasonic frequencies. Due to this filling, colour and clarity gradings have not been assigned. The underrail is broken on one side, close to the central setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques with a fractured filled diamond of similar appearance being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
